<b>11.1</b>	<b>Purpose:</b>
11.1.1	This procedure details the fees associated with accreditation of Inspection Bodies as per the schemes operated by ACCAB.
<b>11.2</b>	<b>Scope:</b>
11.2.1	This schedule of fees is applicable to the various accreditation schemes operated by ACCAB for The Inspection Bodies.
<b>11.3</b>	<b>Responsibility &amp; Authority:</b>
11.3.1	The ACCAB Chief Executive Office oversees the invoice preparation and the fees collection.
<b>11.4</b>	<b>Operation:</b>
<b>11.4.1</b>	<b>General Terms &amp; Conditions:</b>
11.4.1.1	Travel, Lodging & Boarding and Local Expenses: Preferably to be arranged by the applicant/accreditation organization or to be paid in advance to ACCAB at actual.
11.4.1.2	The fees is net payable to ACCAB, local taxes to be borne by the Applicant/Accredited Body
11.4.1.3	<u>Expansion of scope:</u> <ol style="list-style-type: none"> <li>i. If auditor travel mode is other than air and if time required more than four hour then additional charges may be levied.</li> <li>ii. Extra charges will be levied for expansion of the scope which would include auditor remuneration, miscellaneous expanses, administrative charges and ACCAB accreditation fee.</li> <li>iii. Travel lodging and boarding expanses to be arrange by IB.</li> </ol>
11.4.1.4	Any fees once paid shall not be refunded after initiating accreditation/assessment process by ACCAB.
11.4.1.5	The fees is excluding VAT/Service Tax etc.
11.4.1.6	This quotation is valid for 90 days from the date of issue.
11.4.1.7	The fees structure may be revised annually. However, accreditation fees once agreed shall remain valid for the period of three years.
