11.2.1	This schedule of fees is applicable to the various categories operated by ACCAB for GLP Conformity Recognition Programme.
11.3	Responsibility & Authority:
11.3.1	The ACCAB Chief Executive Officer oversees the invoice preparation and the fees collection.
11.4	Operation:
11.4.1	General Terms & Conditions:
11.4.1.1	The fees are inclusive of Assessor Fees/Honorarium.
11.4.1.2	Travel, Lodging & Boarding and Local Expenses to be arranged by the applicant organization or to be paid in advance to ACCAB at actual.
11.4.1.3	The fees are net payable to ACCAB, local taxes to be borne by the applicant organization.
11.4.1.4	Any fees once paid shall not be refunded after initiating accreditation/assessment process by ACCAB.
11.4.1.5	The fees are excluding VAT/Service Tax etc.
11.4.1.6	This quotation is valid for 90 days from the date of issue.
11.4.1.7	This is an introductory fees offer. The fees structure may be revised annually. However, Conformity Recognition Programme fees once agreed shall remain valid for the period of three years.
